SUMMARY OF FINDINGS. In 1999, manufacturers' shipments of computers were valued at \$62.7 billion, a 10.2 percent increase from the 1998 total of \$56.9 billion. Units of computers shipped increased from 23.1 million in 1998 to 28.3 million in 1999. Personal computers were valued at \$26.3 billion in 1999, compared to \$24.5 billion in 1998. Workstations were valued at \$10.2 billion in 1999, compared to \$9.8 billion in 1998. Notebooks were valued at approximately \$7.4 billion in 1999, compared to \$5.8 billion in 1998. Loaded processor boards and subassemblies were valued at \$30.4 billion compared to \$26.0 billion in 1998. Computer storage devices were valued at \$9.7 billion in 1999, compared to \$9.3 billion in 1998. Magnetic and optical recording media were valued at \$3.9 billion in 1999, compared to \$4.7 billion in 1998.
