Welcome to this 43rd New England Circle, another in a series of these gatherings inaugurated here in this hotel more than a decade ago.

As it has since that February evening in 1974, our purpose has remained steadfast: to provide a forum for the discussion of social, political, educational and literary topics that can lead to constructive change in our lives, our nation, and in our world.

The Circle's genesis goes back to the Nineteenth Century when Ralph Waldo Emerson, Henry Wadsworth Longfellow, Charles Dickens and other literary lions of the day gathered regularly at the Parker House for meetings of the Saturday Club. Their lively exchange of opinions and ideas in a hospitable and informal setting are traditions that continue to influence today's Circles: private, non-profit gatherings that have welcomed more than 1800 members from every corner of the region. From the start, this setting has encouraged spirited and open exchanges between Circle discussion leaders and every Circle guest.

This evening's discussion leader is Margarita Papandreou, president of the Women's Union of Greece, international liason for Women For A Meaningful Summit, and wife of Andreas Papandreou, the Prime Minister of Greece. Born in Oak Park, Illinois, the former Margaret Chant began her career as a political activist while she was still in school. A campaign worker at 12 on behalf of her grandfather, and later for Hubert Humphrey and Adlai Stevenson, she hasn't stopped since. Wed in 1951 to the University of California economics professor who would later become one of his nation's leaders, she has led an on-going effort to gain social and legal rights for the women of Greece.

Recent reforms she has helped realize include the abolition of dowries, the legalization of divorce by mutual consent, equal pay for equal work and the legislative action needed to insure it. A year ago, she headed the Greek delegation to the United Nations Conference for the Decade of Women in Nairobi, Kenya; and, in the further interests of global security, she has communicated with both President Reagan and Premier Gorbachev about the pressing need for super-power agreements that will start the process of nuclear weapons reduction.

Please welcome this tireless and lifelong worker for peace and social justice to this, our 43rd New England Circle.
