She speaks with a voice of experience and place. Born in Nicaragua, she has grown up with revolutions. As a former staff member of the Nicaraguan Embassy in Paris - she holds a degree in political science from the Institut des Science Politiques in that city - Bianca brings unique qualifications to her chosen role as a spokesperson for Central America and its people, including the half million refugees currently fleeing El Salvador.

As a person whose commitment has been demonstrated over ten years in a number of Central American nations. Bianca has frequently been invited to share her insights with American institutions and policy makers. Recently. she was a panel member at the John F. Kennedy School of Government discussion of El Salvador. And, following her on-the-scene observations of an attack on refugees at the Honduran border, Bianca testified before an Intra-American Affairs sub-committee of the House Foreign Affairs Committee.
