*American politics and in the Democratic party. The son of a bricklayer from County Cork, O'Neill was born in Cambridge in 1912, attended St. John's High and was graduated from Boston College in 1936.*

*In that same year, he was elected to the Massachusetts House of Representatives. He was elected Minority Leader in 1947 and became Speaker in 1948. In 1952, O'Neill was elected to the Congressional seat being vacated by John F. Kennedy. In Washington, he became a member of the Rules Committee and was later chosen Majority Whip and Majority Leader. In 1941, he married the former Mildred Anne Miller. They have five children.*

*In January of this year, he was elected Speaker of the House, the fourth Bay Stater in this century so honored. The others were Frederick H. Gillett, Joseph W. Martin, Jr., and John W. McCormack. Speaker O'Neill's constant motto has been "All politics is local." His interest in the New England economy has led to increased cohesion and assertiveness among the Region's delegation in Congress.*
