*Welcome to the New England Circle . . .*

*Our purpose is to assemble for discussion of social, political, literary and educational topics; our goal is to exchange ideas and opinions that can lead to constructive change in our personal lives and in our nation.*

*Edward I. Koch, the 105th Mayor of New York City, will lead our discussion for the thirteenth meeting of the New England Circle.*

*Edward Irving Koch was inaugurated Mayor of New York on January 1, 1978, assuming a job often described as the nation's second-hardest. Since taking office, Ed Koch has initiated wide-ranging reforms to bring, as he describes it, a "renaissance" for the "urban pioneers" of his native New York City.*

*Drawing on nine years experience in Congress, Ed Koch has instituted reforms in the city's personnel procedures and budget policies. He has proposed major changes in the city's civil service system, and introduced major legislative initiatives in educational and housing rehabilitation.*

*Ed Koch first assumed elective office in 1963 when he defeated former New York County Democratic Leader Carmine DeSapio for the Greenwich Village Democratic leadership. In 1966, he won a seat on the New York City Council, the first Democrat to represent his district in 38 years. Two years later he was elected to the U. S. House of Representatives from Manhattan's "Silk Stocking" District. He was re-elected four times to the House, earning recognition from his fellow City Congressmen as their "most effective Congressman" for his outstanding record in urban affairs, human rights, health care, and support for the arts.*

*A World War II veteran, Ed Koch attended City College in New York and received a law degree in 1948 from New York University Law School. When not pressing the City's cause in Washington, D. C. or Albany, Ed Koch can be found on the street-corners of New York.*
