In 1985, survey MA36N was divided into three annual surveys which are presently collected as: MA334P, Communication Equipment, Including Telephone, Telegraph, and Other Electronic Systems and Equipment; MA334Q, Semiconductors, Printed Circuit Boards, and Other Electronic Components; and MA334S, Electromedical Equipment and Irradiation Equipment (Including X-Ray).

Beginning in 2005 data for the MA334Q was collected under the title Semiconductors, Electronic Components, and Semiconductor Manufacturing Equipment.
