

 Monitoring and Evaluation

 Poor Solid Waste Management has been one of the major environmental problems that exist in Cities, Municipalities and District Councils in many Countries, especially developing countries like Tanzania.
 Experience has shown that not all generated solid waste is collected, disposed or recycled.

INTRODUCTION

Introduction cont.....

- In the recent past, most councils have resorted to privatization of the solid waste management as one of the solutions to solid waste management crisis.
- The Dodoma Municipal Council is one of the Municipalities which have contracted the solid waste collection to community based organizations (CBOs). Among which is the Mazingira Women Group.

Background of the CBO

- The Mazingira women group comprises of 20 members of which 7 are men.
- It started its activities in 1999 on a self help basis.
- It operates in Majengo ward which has four mitaa, 660 households, an average household size of 3.9, a population of 6901 of which 3,308 – male and 3,593 – female.(2002 census)

Vision:

 Dodoma Municipality with clean streets free from accumulation of garbage and all solid wastes.

Background cont...

Mission:

 To promote environmental sanitation through community participation by the year 2015.

Objective:

To collect garbage around the streets and dispose in strategic centers ready for shipment to designated disposal areas

Community needs assessment

- The community needs assessment was carried out in October 2006 to determine the capacity building needs for the CBO and the general public to ensure improved solid waste management in Dodoma town
- According to the group, the following are the criticalissues

Community needs assessment cont....

- Need for back up from the Municipal leadership to assist them during sensitization meetings
- Support from the Mitaa leadership in convening community meetings
- Resources for the operation of the project.
 These can be obtained through selling of recyclable materials like plastics but also by producing and selling compost manure.

Problem statement

- Although there is a growing emphasis on the need to privatize some of the former public services like solid waste management, the private operators need government support to enable them deliver effectively.
- During the needs assessment on improving solid waste management in Dodoma Municipality, it was found that
- generally poor collection of solid waste generated as well as disposal of the same
- Shortage of the needed tools, equipment and machinery
- weak coordination mechanism,
- limited community mobilization skills.

Justification of the study

- One of the current development agenda in Tanzania is encouragement of private sector to champion development process and the participation of community in all aspects that affect their development.
- Mazingita Women Group has emerged as one of critical initiatives in Dodoma by the community to address one of the environmental problems. The group has been working with the community for more than five years now, and there are issues to be learned for future improvement of its own activities as well as other similar organizations.
- This study reveals the successes and failures, and the underlying reasons with the view to come up with better strategies for the future.

Research questions

- 1. Is there any difference on the management of solid waste between now and when there were no private organizations?
- 2. Is there a relationship between private sector participation and sustainability in the management of solid waste?
- 3. What opportunities exist for further improvement of the involvement of communities in solid waste management?

OBJECTIVE OF THE STUDY

 The objective of the study was to assess the performance of the CBO in relation to solid waste management and find out what can be done in order to improve the performance of CBOs so as to bring about sustainability in the whole question of solid waste management.

Methodology


- Interviews using structured questionnaires were conducted to heads of households on their views on the effectiveness of the group in collecting solid waste, participation of the community in the solid waste collection and contribution to the cost in terms of payment of prescribed fees and the role of Municipal Authority in facilitating the group.
- Formal and/or informal discussion was also used to solicit views from other stakeholders.

Sample size


A sample of 212 respondents was drawn. The
distribution was such that, there were 200 heads
of households and commercial traders
(community members), 4 officials from CBOs, 3
staff of Dodoma Municipal Council, 1 Ward
Executive Officer, 4 Mtaa chairpersons.
Structured questionnaire were used for
household survey, a check list for key informants,
interviews and focus group discussions.

Data analysis and presentation of findings

 Data analysis was done using statistical package for social science (SPSS) and results are presented in form of tables and graphs.

Research question 2

- Is there a relationship between private sector participation and sustainability in the management of solid waste?
- Yes, because if you involve the people then chances are that they will own the process (this is what is happening in Majengo currently)

Research question 3

- What opportunities exist for further improvement of the involvement of communities in solid waste management
 - 95.% of the respondents said that there is a need for intensive mobilization meetings so as to enhance community participation.

CONCLUSION

- The involvement of private sector (CBO) contributes positively towards sustainable solid waste management in municipalities. However, these CBOs need to be capacitated in order to effectively render their services
- Full community participation in terms of paying collection fee is a crucial factor in bringing about sustainability in terms of enabling the CBO to meet running costs.

Conclusion cont...

 These findings are not different from other surveys done on the same topic elsewhere

RECOMMENDATIONS

- There is a need for the Municipal council to assist such groups in terms of
- a) Capacitating CBOs that deal with solid waste in terms of training so as to enable them to perform effectively
- Effecting by laws which have been enacted in order to task those who do not pay garbage collection fee as well as those who throw garbage in the streets

Implementation

- Name of project: enhancing CBOs capacity in the collection and disposal of solid waste in Municipalities – the case of mazingira women group-Dodoma municipality
- Objective
 - -To train the CBO members on how to produce compost manure

20 members of the group were trained on how to produce compost manure. The training was facilitated by the Ward Community Development Officer for Majengo ward. The training was undertaken in November 2006.

Monitoring

Monitoring had been an ongoing exercise from the initial stages of the project.

- a meeting was convened in which 7 steps were developed as the methodology to be followed in the monitoring process;
- The purpose of monitoring was reviewed to see whether monitoring will help the group members.

Monitoring cont...

- · review the objectives and activities
- · Development of monitoring questions,
- · Establishment of indicators
- · Deciding on information gathering tools
- · deciding who will do the monitoring
- · Analyze and present results

Monitoring cont...

- During implementation monitoring was done on a daily basis. The Community Development Officer, two group members and the Ward Executive Officer collected data
- The data was collected using the attendance register, Other tools used include observation

Monitoring cont...

 The monitoring team was appointed by a community meeting which was convened earlier to decide who will be monitoring the implemented activities.

Evaluation

 Evaluation will be carried out in May 2007 as was planned. The evaluation will focus on impact of the training in terms of how has the training assisted the members.

The project advisor discussed through a focus group discussion the benefits of participatory evaluation which are:

Evaluation

- · Helps in making better decisions
- · Develop evaluation skills for group members
- Develop mutual understanding among the group members and advisor
- Provide useful information for ongoing management of the project

Evaluation cont...

- The general meeting of the group members and key stakeholders will appoint the evaluation team. The composition of the evaluation team will include group members and outsiders. The members will not be paid because it is part of their duty.
- The results of the evaluation team will be presented to a meeting within a week after evaluation to allow timely decision.
