*She helped found New York Magazine, she has worked as*

*an editor for publishers like Curtis, Conde Nast and McCall's — who named her Woman of the Year in '71.*

*She has been awarded a cluster of honorary degrees, a shelf of national and international awards, and she serves on a number of boards and advisory committees — enough to establish her as one of the most diligent citizens in the nation. A writer, a journalist, a speaker, an organizer, a political activist, a leader of conferences, an editor, and one of the prime forces at the helm of a successful national magazine. It is a wonder that Gloria Steinem has never allowed any of her considerable accomplishments to blur her most prominent identity and achievement — her commitment to women, women's rights, and the rights of all minorities.*

*Her name is a synonym for one of the most significant movements of the century, a movement she now energizes as an editor and writer for Ms. Magazine, and surely a movement which she will continue to lead for decades to come, or until all women everywhere possess every right Gloria Steinem believes they must have.*
