

#### PROSPECTUS

#### Job Corps 24 (Working Draft)

#### **Objective:**

- 1. To select 24 welfare or homeless persons for 24 months of job training in house building skills
- 2. To renovate eight unoccupied houses in the Empowerment Zone, one each quarter for two years
- 3. To help to stabilize one or more blocks with renovated housing.
- 4. To equip two of these houses as transitional housing for homeless persons and to staff these houses
- 5. To create a new home improvement enterprise for the inner city

#### Management:

Job Corps 24 will be managed by Respond, Inc. through coordination of the appropriate programs of Respond. These include the PATH Program (Providing Assistance to The Homeless), the GA/FDP Program of welfare management (General Assistance/Family Development Program), and State Street Housing Corporation. Trainces will be identified among those now being served, the housing stock will be selected from the properties now owned by State Street Housing, and initial training provided by inner-city contractors now employed. Training will be provided in six areas: carpentry, heating and plumbing, electrical, masonry, roofing and painting.

The transitional houses will be permanent units in the PATH program. The other houses will become part of State Street Housing's rental and homeownership program.



# "Friends House" for HIV+ Women Opened by AIDS Coalition

#### FIRST IN THE REGION

On July 1, the AIDS Coalition will open the first transitional housing program dedicated to women with HIV/AIDS, the only one of its kind in the region. The new site is located on Haddon Avenue in downtown Collingswood.

"Friends House" will house five HIV<sup>+</sup> women and a resident manager. "Friends House" is comprised of two separate, spacious apartments; each of which will house three women in private bedrooms plus a living room and kitchen-dining area.

These apartments will be used as transitional housing for women who need a 'safe haven' for up to 24 months; it affords them time to stabilize their lives with the support services of the AIDS Coalition.


The residents of "Friends House" will receive many free services that will stabilize their lives and lead them toward permanent housing. The AIDS Coalition will provide case manage-

ment, Buddies, Positively Nutritious, legal services, support groups, clothing, employment counseling and programs for women who have children.

The purchase of this property was made possible by grants from HUD and the NJ Department of Community Affairs. The Coalition's Property Management Committee oversees the physical and financial issues related to Friends House and four other Coalition properties. The Housing Subcommittee of the Coalition's Client Services Committee establishes housing criteria, selects the residents and manages the delivery of services. \*

#### THIS PAST YEAR

#### **EXPANDING SERVICES**

- the purchase of the Bellmawr property, which will be transitional housing for six men.
- the purchase of the Kenneth Levy House in Mount Holly.
- the expansion of housing into Gloucester County.
- the creation of a job bank, for those clients faced with re-entering the job market due to more effective medications which are now giving us all a glimmer of hope.

All of these things are possible because of the efforts of Tom Sauerman, the Executive Director, the staff, the Board of Trustees, and all the volunteers.

### Meet the Residents of the William A. Cole House

On April 1, 1997, Jeff, Jim, Kevin and Sam became the first residents of the newly renovated and fully furnished William A. Cole House on Haddon Avenue in Camden.

These men, in their 30s and 40s who were at risk of becoming homeless, now have their own bedroom with TV. They share a phone, living quarters, and a kitchen stocked by the AIDS Coalition with non-perishables. The NJ Transit bus stops at the front door and the PATCO High Speed Line is one block away.

They were recommended by their case managers for this transitional housing, which is convenient to Our Lady of Lourdes Medical Center and treatment programs.

Resident manager Darrell Crone says, "This is an ideal living environment for these men." An ex-Marine, a Drug and Alcohol Counselor, and manager of the PATH day program for homeless men, Crone says he makes sure they're a cohesive unit and live by the Coalition's rules.

Jim explains that he had to move out of a slumlord's house when he was laid off from his job as a forklift operator. "Being here is helping me break the (addiction) cycle," he says. It's also giving him the space to finish his book, "Final Request," which is a reflection of his life

as he comes face to face with death.

**Sam**, formerly a 4th grade teacher, intends to make a new life for himself here. A 15-year U.S. Marine veteran who served in the Desert Storm operation, he says this home "was God-sent to me. It's taken a lot of worry off me, 'cause it's hard finding a decent and safe place to live."

**Jeff** headed building maintenance for a company. He says, "The house is gorgeous, comfortable and quiet, which I love." He's looking forward to helping the Coalition by using the plumbing, heating and electrical skills he learned when he worked with his father for 10 years.

At the time this was written, **Kevin** was hospitalized and was unavailable for an interview. \*

### Employment Counseling and Job Bank Proposed for New Service

The 1997-99 Strategic Plan recently approved by the Board of Trustees included a new service for persons with HIV/AIDS: "Rise Up!" is a program which provides employment counseling and offers a job bank to assist in finding both full and part time jobs.

The recent advance in medications has stabilized and improved the health of many clients. Some who have been on disability are ready to return to the work force.

"Rise Up!" will hire an employment counselor to prepare them for changes in employment, interviewing skills and



re-entry to a different job. The program will also hire a professional to seek out agencies that will offer employment. It is anticipated that this new program will be in operation by the end of 1997.

The 1997-99 Strategic Plan focuses on seven major goals for the AIDS Coalition. Four of those goals address clients (needs assessment, evaluation, care and consumer diversity). For a copy of the plan, call the AIDS Coalition office. �




