Dean George J. Larkin of Student Personnel Services reports several students have asked a the rationale involved in submitting medical and health evaluation forms as requirements for matriculation at New Hampshire College, as well as at most other colleges in the country. The following is a response from the Health Center:

Medical Evaluation and Examination in College is nothing new. The first program in student health, initiated at Amherst College in 1859, under the direction of Dr. Edward Hitchcock, included among its activities a health examination upon enrollment and annually thereafter. Dr. Hitchcock, the pioneer and dominant figure in student medicine for over 50 years, considered this examiniation one of the most important features of the college health program.

Twenty years ago at the Third National Conference on Health in Colleges, the primary objective on the list was, "Complete medical examination of each student upon entering the College. This should be considered as a matriculation requirement and should be completed shortly after the beginning of the college term."

#### Why Any Medical Evaluation or Examination Before Enrollment?

#### 1. Preventive Medicine

The early detection of disease and provision of sound medical advice in regard to a newly discovered abnormality would seem to be a reward from almost any "routine" medical examination. This would apply to an examination carried out at the time of enrollment in college.

#### 2. Health Education

A medical evaluation and examination should be an experience in health education emphasizing the importance of such a procedure and also demonstrating areas of concern or importance in the future life of the young adult.

#### 3. Protection of the Campus Population

The presence of a contagious disease in a student arriving on a college campus would certainly represent a threat to other students as well as a challenge to the responsibility of the college administration. The most common example of such contagion would be tuberculosis.

#### 4. Transfer of Responsibility for Medical Care

A continuing responsibility for medical care would seem to be best based upon a foundation record which indicates the past history and current condition of the patient. A requirement for medical and health evaluation upon enrollment in a college must not be interpreted by either the student or the physician as a screening procedure upon which eventual enrollment is dependent. Information is used only as a background for providing thoughtful health care. It does not jeopardize school status.

# 5. Demonstration of Concern for Health by the Institution

Students and their parents, in an increasingly health-centered society, are reassured when the academic institution demonstrates a concern for the health status as well as the maintenance of health in the young adult embarking on an academic career. National recognition of this responsibility in higher education was given by the President's Commission on Education in listing the eleven objectives for education, the commission included four which were directly related to health.
