## HISTORICAL NOTE

The Census Bureau has collected data on selected electronic and associated products since 1961 on survey MA36N, Selected Electronics and Associated Products. In 1985, survey MA36N was divided into three annual surveys which are presently collected as: MA334P, Communication Equipment, Including Telephone, Telegraph, and Other Electronic Systems and Equipment; MA334Q, Semiconductors, Printed Circuit Boards, and Other Electronic Components; and MA334S, Electromedical Equipment and Irradiation Equipment (Including X-Ray).

Beginning in 2005 data for the MA334Q was collected under the title Semiconductors, Electronic Components, and Semiconductor Manufacturing Equipment.
