Our Guest Speaker for the eighth meeting of the New England Circle is Congressman Andrew Young, who has represented the Fifth Congressional District of Georgia since 1972.

Andrew Young was a close associate of Dr. Martin Luther

King, Jr., and a leader in the civil rights movement of the 1960's.

The New York Post has commented, "Congressman Young, the first black elected to Congress from the South since Reconstruction, is being described as a 'Kingmaker' and 'America's most powerful black' because he put Carter over with blacks."

According to The Boston Globe, "Although Young has been mentioned as a likely candidate for United Nations Ambassador or to serve as a top State Department official, Young said he is not interested in an appointment. President-elect Carter, expressing regret at Young's decision, called the Georgia Congressman 'the best elected official I have ever met.'"

Congressman Young has been active in the successful effort to continue and strengthen the Voting Rights Act, and is a member of the House Rules Committee.

A graduate of Howard University and the Hartford Theological Seminary, Congressman Young is an ordained minister in the United Church of Christ.

Previous New England Circle Guest Speakers have been Richard N. Goodwin; Dr. Henry Steele Commager; Former Governor of Maine Kenneth Curtis; Georgia State Senator Julian Bond; Massachusetts Congressman Michael Harrington; Massachusetts Senator Edward M. Kennedy; and Journalist Jimmy Breslin.
