

Welcome to the first dinner discussion of the New England Circle, with Guest Speaker, Richard N. Goodwin. Dick Goodwin, coiner of the phrase, "Alliance for Progress", and author of a new book, **THE AMERICAN CONDITION**, was one of President John F. Kennedy's most trusted speech writers. Arthur Schlesinger in **A THOUSAND DAYS** remembered Richard Goodwin as "a man of uncommon intelligence, perception, and charm. . . who soon proved himself more skilled in writing for Kennedy than anyone other than Sorenson." After President Kennedy's death, Dick Goodwin became a noted speech writer for President Lyndon B. Johnson. In 1968, he ran Senator Eugene McCarthy's New Hampshire campaign, worked for Senator Robert F. Kennedy until his assassination, and ended that election year by writing Senator Muskie's famous Election Eve speech.
