

Introduction

- Organization; Community Youth Educators Organization (CYEO)
- Location: Mburahati ward, Kinondoni Municipal –Dar es Salaam.
- Goal: To reduce HIV/AIDS spread among youth in Mburahati ward



Intro cont....

Major activities of the host CBO

- Conduct HIV/AIDS preventive education to youth groups in the ward through seminar
- · Group discussion with youth camps
- · Cultural/drama group



Need assessment

- Needs assessment through; interviews with CBO members, leaders, stakeholders &review of secondary data.
- 143 people died with HIV/AIDS cases as of Dec 2005 (Source; Municipal AIDS Coordinator Office)
- 124 people are living with HIV/AIDS (Mburahati voluntary counseling centre)



Need assessment cont...

■ The assessment revealed the need to assess the impact of HIV/AIDS awareness/education to youth in the ward



Statement of problem

- Present knowledge on the spread of HIV/AIDS is very high as reported by many researchers (Tumbo-Masabo, 1996, Global AIDS epidemic, 2004 and Weiss, 1993).
- But the gaps remain in understanding of HIV/AIDS prevention, especially with respect to male, female and adolescent girls
- Need for assessing impact of HIV education arose.



Objective of the survey

 Overall objective is to assess the impact of CYEO HIV/AIDS awareness/education to youth in Mburahati ward.

Specific objective

- Assess and analyze level of HIV/AIDS knowledge among youth from CYEO
- Assess contribution of stakeholders in HIV/AIDS education
- To assess the effective methodology for behaviour change



Literature review

- Over 70 percent of those infected are aged between 20 49 years, and the infection rate is higher among the younger in this group
- Peer education has a positive implication on improving knowledge on HIV/AIDS



Relevant researches

- There are many e.g.- assessment of NGO and peer educators by Wanjama et al in 1998
- Assessment of sexual attitude and behaviour by Stella et al 2003
- Concluded to have a measurable positive impact in the key area of improving knowledge, attitudes and practices related to risky sexual behaviour



Research questions

- What CBO in your locality educate about HIV/AIDS?
- Where is it located?
- What was the last message do you remember hearing from them?
- What other sources of information have you heard messages on HIV/AIDS?

Research methodology

- Research design cross sectional design were data were collected at a single point in time
- Sampling techniques stratified random sampling
- Instrument- Interview and questionnaires
- Sample size 90 (youth) respondents from 18 youth camps (strata)
- Response rate was 98%



Methodology.....

- Descriptive statistical method in data presentation and mainly use of percentage
- **Data analysis** SPSS computer programme were used to analyze the information



- Mean age was 19.4 for male and 19.3 for female






Exposure to teaching methods


- 38.9% recall the discussion method

- 38% got preventive education
- 25% from BCC activities
- 27% from counseling centre





Findings

- 45% knows that youth are in dangers of getting HIV
- 30% knows that prostitute can be infected.
- 15% poor people are susceptible to disease
- 10% marriage couples are in danger.
- All respondents 87% knows and have heard about HIV/AIDS



Findings

- 47.8% of respondents knows CYEO while 42.2% they don't know.
- Discussion method was recalled and leading by 38.9% followed by cultural shows 27.8, seminar 15.6% and drama was 2.2%.
- Education from other source were 29% from prevention stakeholders, 15% from BCC, 16% from counseling centers.



Recommendations

- The CYEO should collaborate with other organization for reaching more youth in the ward.
- More effort is needed to reach female youth who are more susceptible to infection.
- A proper incentive system is needs to be instituted to increase the number of sessions.
- The peer educators should be trained well to be more competent for effective behaviour change communication.

Recommendation cont....

- More support from the government to CBO is needed in term of materials
- Implementation of other program on income generation activities
- Consistency use of training manual



 Effective intervention for adolescent and sexual behaviour should include multiple channels of communication



Conclusion

- The community Youth Educator Organization is fairly conducting well its intervention despite the fact that effort is needed to increase HIV/AIDS education to the youth camps in the ward.
- The survey concluded to have measurable positive impact in the key area of improving knowledge, altitudes and practice related to risky sexual behavior



Implementation of recommendations

- Training of peer educators on how to use training manual Sept 2006
- Initiate another income generating activity by January 2007
- Instituting proper incentive scheme for increasing more training sessions March 2007
- By June 2007, 70% of youth in Mburahati ward will be reached by CYEO activities.



Monitoring

- Monitoring will be done on monthly basis to keep the track of the program i.e. filling forms, activities report on training sessions, gender of youth reached, inventory of material distributed,
- Allowance given to trainers in relation to number of session conducted



Evaluation

- Evaluation will be on going though meeting with all stake holders on monthly basis
- Annual evaluation- June 2007
- > Review project objectives
- > Evaluating effectiveness and efficient of the project
- > Review project resource



Evaluation cont...

Two strategies will be used Summative evaluation

■ Will be conducted to evaluate the impact of training on life/working performance of the community as community without HIV/AIDS is active and productive while affected community are likely to be poor.

Formative evaluation

 Will evaluate the performance of the training manual in relation to the community understanding and peer educators' usability for improvement, sustainability and the productivity obtained.



Performance indicators

- Number of youth going for HIV counseling and testing
- Number of youth who are willing to disclose their HIV status
- % of potential partners & collaborators involvement in the program implementation



Performance indicators cont...

- Number of youth who will attend the sessions
- Number of behavior change communication activities conducted, reading material distributed
- Quantity and quality of sensitization sessions conducted to youth groups



Sustainability

- Working in collaboration with other organizations i.e. Municipal AIDS coordination office, TACAIDS, counseling centre, etc
- Consistency use of training manual by peer educators
- On going hiring of cultural group CBO income
- Participatory planning of interventions and by using local resources available
