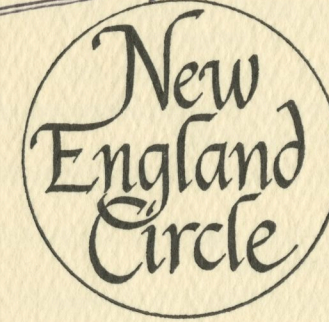

Welcome to the seventh New England Circle with Guest Speaker Author and Reporter Jimmy Breslin.

Our purpose is to assemble with others for discussion of social, political, literary, and educational topics, having as a common goal the exchange of ideas and opinions that lead to constructive change in our nation and in our personal lives.

According to Bob Healy, Political and Executive Editor of The Boston Globe, "Jimmy Breslin is one of America's great reporters, authors, and storytellers. He has that great knack of taking a slice of America and telling peo-

ple about it. It can be a Selma, Alabama; a Democratic National Convention; or the story about Marvin The Torch and Fat Thomas, at a Queens, N. Y. bar.

He has come a long way since he left John Adams High School in The Queens, a school which, he told a Harvard Class Day audience in 1971, 'turned out 15 cops; 15 firemen; 16, no 17 fairly prominent felons; and 75 body and fender workers, who are open to any proposition.' And, of course, Jimmy Breslin.

Breslin started his newspaper career in Boston and worked his way to New York, where he was a reporter and columnist for the New York Herald Tribune. He strayed from the business only once, when he ran for Office in New York City and was defeated. He is the author of three books, THE GANG THAT COULDN'T SHOOT STRAIGHT; WORLD WITHOUT END, AMEN; and HOW THE GOOD GUYS FINALLY WON."

Previous New England Circle Guest Speakers have been Richard N. Goodwin, Dr. Henry Steele Commager, Former Governor Kenneth M. Curtis of Maine, Georgia State Senator Julian Bond, Massachusetts Congressman Michael J. Harrington, and Massachusetts Senator Edward M. Kennedy.
