SUMMARY OF FINDINGS. In 1999, manufacturers' shipments of coin-operated vending machines totaled \$1,038.8 million. Shipments for beverage vending machines totaled \$741.0 million. The amount of vending machines for confections and foods was \$246.2 million in 1999.
