Welcome to our New England Circle, another in the series that is now well into its second decade.

As it has been for more than eleven years now, our purpose is to assemble for the discussion of social, political, literary, and educational topics; our goal is to exchange ideas and opinions that can lead to constructive change in our lives, our nation, and the world.

Our discussion leader this evening is William Hodding Carter, III.

After his graduation from Princeton and two years of service as a United States Marine, Hodding Carter began a career in journalism with the Delta Democrat-Times in his native Greenville, Mississippi, that would establish the patterns of his distinguished career for the next 35 years. In keeping with the high standards of fairness, truth, courage and a commitment to human rights set by the paper's then editor and publisher, father Hodding Carter, Jr., this son of the deep south continued to champion the cause of civil rights where those rights were often most in jeopardy.

That concern for public affairs, his commitment to the struggle that then, and now, continues to be one of the nation's most pivotal issues, moved him toward politics and government: the arenas where the battles for human rights are so often decided. A campaign coordinator for both Lyndon Johnson and Jimmy Carter, he was later appointed Assistant Secretary of State for Public Affairs during the Carter Administration.

But it was journalism that remained his first priority. As the author of "The South Strikes Back," a regular columnist for the Wall Street Journal and a frequent contributor to the nation's leading periodicals, he had established a national reputation when he became the anchorman of the award-winning Public Television series, "The Inside Story," now completing its fourth year.

During this winter, Hodding Carter is preparing a new, independent television production; titled "MaineStreet," its first focus will be the workings of the U.S. Congress. And, also this year, this busy and committed man, was named, with his wife, Patt Derian - a well-known human rights activist - an associate editor of WorldPaper, the monthly journal published in Boston that addresses issues of global concern.

Welcome, Hodding Carter, to this evening's Circle.
