*While an undergraduate he wrote several articles for the Harvard Law Forum when he first became interested in automotive safety. As a crusading attorney, Nader first made headlines in 1965 with his book "Unsafe at Any Speed," the scathing indictment that lambasted the auto industry for producing unsafe vehicles.*

*Currently Mr. Nader's organization, Public Citizen, is concentrating its efforts in the areas of nuclear power, campaign reform and the establishment of "Congress Watch Local" chapters in congressional districts across the country. Congress Watch Locals monitor the local member of Congress. The ultimate goal of this movement is to provide citizens with a vehicle to register their collective opinions and endorse those remedies which are intended to achieve a better society.*
