## Summary of Findings

For 2000, value of shipments of the types of construction machinery included in this report, except motor graders and light maintainers, scraper bowls, construction machinery for mounting on trucks, tractors, etc., and winches and other materials-handling equipment for

mounting, increased 1 percent to \$15,403.5 million from \$15,260.9 million in 1999.

Shipments of power cranes, draglines, and excavators, including surface mining equipment, and attachments for 2000 were \$3,037.3 million, down 3 percent from the previous year's total of \$3,124.7 million.

Value of shipments of mixers, pavers, and related equipment decreased from \$1,608.2 million in 1999 to \$1,494.2 million in 2000, a decrease of 7 percent. Off-highway trucks, truck-type tractor chassis, trailers, coal haulers, or wagons increased by 2 percent in value of shipments to \$855.2 million in 2000 from \$834.6 in 1999.

Shipments of tractor shovel loaders increased from \$4,049.2 million in 1999 to \$4,188.6 million in 2000, an increase of 3 percent. Crawler tractors, contractors' off-highway wheel tractors, dozers, and self-propelled wheeled log skidders increased by 4 percent, from \$1,382.2 in 1999 million to \$1,431.0 million in 2000. Rollers and compactors decreased from \$590.2 million in in 1999 to \$570.6 million in 2000 for a total of 3 percent.

Shipments of rough terrain forklifts (integral units only) decreased by 11 percent to \$549.2 million in 2000 from \$616.8 million for the prior year. Ditchers and trenchers, self-propelled (integral units only) decreased from \$287.4 million in 1999 by 1 percent to \$283.5 million for 2000. Construction machinery for mounting on trucks, tractors, and other prime movers, except winches, hoists, and other materials-handling equipment moved from \$274.8 million in 1999 to \$311.2 million in 2000, a 13-percent increase. Aerial work platforms increased by 8 percent from \$2,491.8 million in 1999 to \$2,682.7 in 2000.
