Welcome to this very Special Reunion Assembly of the New England Circle. This evening's gathering brings together, for the first time, many of the more than 800 Circle members who have been to our 18 previous dinner discussions and other Circle events held here at the Parker House since 1974.

We are especially honored by the presence of this evening's Discussion Leader, Sweden's Under-Secretary of State for Disarmament, Inga Thorsson, and many of our former Circle Discussion Leaders, and several Special Guests.

We are gathered to listen to and participate in a discussion of the critical issue of our time: our responses and strategies for a nuclear age. We come to talk about ideas which are sweeping the nation and the globe. We are here to contribute to a rational agenda for our nuclear—or non-nuclear—future.

This Special Assembly is in keeping with the best traditions of the New England Circle's purpose: *to assemble for the discussion of social, political, literary and educational topics; to exchange ideas and opinions that lead to constructive change in our lives, in our nation, and, as this evening's topic mandates, throughout the world.*

For there are no national boundaries to the nuclear arms race. The issue is planetary, as our Discussion Leader so well knows. For more than two decades, Inga Thorsson has been grappling with nuclear issues in the conference rooms and lecture halls of dozens of nations. She wrote her first book on the topic in her native land (*No to Swedish Atomic Weapons*) in 1959, and since then has not left the arenas of international diplomacy and disarmament. A member of the Swedish Parliament for a decade, her country's Ambassador to Israel from 1964 to '66, she has been chairman of the Swedish Disarmament Delegation to the United Nations since 1973, a post she has held in conjunction with her work as President of the Non-Proliferation Treaty Review Conference held in

Geneva in 1975. Last October, as chairman of a group of governmental experts working on a United Nations study of the relationships between disarmament and development, Ms. Thorsson and her committee completed more than three years of work on the analysis. The project involved more than 100 researchers and dozens of experts appointed by the UN Secretary General.

Her "committee" this evening includes the assembled past Circle Discussion Leaders, and our Special Guests, each of whom has been on the leading edge of the national and international debates, conferences and movements that are shaping our nuclear futures. And her committee also includes each of you, for, as Circle events have demonstrated since our first meeting more than eight years ago, these are participatory discussions designed to promote constructive change.

As a discussion catalyst, we begin the meeting with a showing of the film *The Last Epidemic*, a 35-minute, award-winning documentary that has the distinction of being specially shown to members of both the U.S. House and Senate.

In this nuclear age, such change is actively sought and acutely needed. As national political columnist Hugh Sidey wrote recently in one of his *Time* columns: "We have built ourselves into an era of nuclear absurdity. We have created a glittering armada of rockets, warheads and electronics controlled by the unfathomable workings of the minds of a few frightened men. . . . America's march up the nuclear mountain was made in the name of peace. The time for a courageous march down, under the same banner, may be at hand. . . ."

This evening's Special Reunion Assembly is one step in that march. We are pleased to be a part of it.
